<u>DATE/TIME</u>: Optional 2 or 3 Day Regional Tournament. Fri. Sept. 27th, Sat. Sept. 28th, and Sun. Sept. 29th, 2019.

Friday Practice will be available from 1:00 pm to 6:00 pm Friday Relay will start at 6:00 pm (a mixed 22/CF/45 stage). Sat and Sun Relays start at 8:30 am

ELGIBILITY: Open to any competitor. Teams will consist of two (2) or four (4) firing members, an alternate, a captain and/or coach, and will represent either a club affiliated with NRA, service unit, or a State Association. Pick-up teams are not allowed.

ENTRIES: We have 36 firing points and will accommodate all entries by firing multiple relays if necessary.

Use the attached Registration Entry Form accompanied by check or money order. Make checks payable to NWTF&S Assn. Circle the number of each event in which you wish to fire. Be sure to indicate your correct NRA number, Classification, and any special Category. Relay preferences will be honored (note: those wishing to fire their individual matches in two days on Friday/Saturday or Saturday/Sunday will be accommodated). Confirmation will be made only if the competitor indicates their e-mail address or includes a SASE. Post Entries will be accepted at the range to 8:00 am, Sat, September 29th.

<u>RANGE FACILITIES</u>: Competition will be held on the Pistol Marksmanship Range, The range is a covered firing line with 36 firing points, turning targets, and restrooms at the range. Camping is available, call for specifics.

The range has a full club house with rest rooms and areas for breaks and eating (must bring own lunch). Drinks are available.

<u>RULES</u>: Current NRA Conventional Pistol Rules and Classifications will govern. **Note ECIs are required**. See CMP Rules for Leg Match.

ENTRY FEES: Pre-Entry Closes Monday, September 16, 2019, an additional \$5.00 Post Entry Fee applies to entries postmarked after that date.

<u>Junior Shooter</u>: Juniors under the age of 18 Must have a hand gun authorization form signed by their parent or guardian. A form is included with this program.

SOUVENIR AWARDS: Each competitor will be issued a NRA Regional souvenir.

<u>AWARDS</u>: NRA Regional Championship Awards - Match 16, Furnished by NRA, Regional Winner Gold Medallion, 2nd Silver and 3rd Bronze. Trophies for individual classes and other awards as posted at range. Competitors may receive only one individual award.

NWTF&S Assn. will provide Cash awards for each match as posted at range (no cash awards to Juniors).

COURSES OF FIRE: Friday 1st Mixed Relay 22/CF/45. (Adverse weather may affect timing)

Saturday 2^{nd} 2^{2} Relay, CF Relay, 1^{st} 22 Team and CF Team, and NRA DR/CMP Pistol Leg Relays. Sunday 45 Relay, followed by 45 Team (12:00 pm), 3^{rd} CMP Pistol Leg Match (1:00 pm), CMP 22 Rimfire Leg Match and NRA DR Match.


REQUIRED EQUIPMENT: **ECIs** for guns and EYE and EAR PROTECTION required for all at all times while under firing line cover.

<u>MATCH CONDITIONS</u>: Stat office will issue score cards. Scoring will be done down range. Scorers and competitors will sign and turn in the score cards at the end of each match fired. Range personnel will assist in all ways possible to avoid unnecessary delays.

NRA Distinguished Revolver Match: See NRA Rule 3.1.4. Revolver firing 158 grain lead round nose or semi wad cutter 38 cal Special (see current NRA rules).

<u>DIRECTIONS</u>: The NWTF&S Daume Marksmanship Range is located north east of Wichita Falls. From Wichita Falls drive east on FM 171 (Airport Rd.) past the entry to the municipal airport and turn left onto Emmert Road (aprox 2 miles). From Emmert Rd. turn right (only choice) on Old Friberg Rd (aprox 1 mile). The range is approximately 1/4 mile on the right. Report in at the Pistol Club Building to sign-up for the matches.
