### 4-H SHOOT

This year's 4-H shoot was the largest 4-H event held ever for the NWTFS. 155 kids signed up from over 13 counties in the surrounding area. The events started on Saturday around 9 am and normally would wrap up around 3 pm. This didn't happen in as we had some pretty unsavory weather for most of the day. The good news was that we did get everything kicked off to a great start and was able to complete more than half the shooting before lightening so rudely reared it's head causing several breaks.

Even though the weather eventually made our fishing day potentially hazardous, the shooting events that were able to be fired were safely carried out by both children as well as all the staff supervising. 4-H shooters at NWTFS were very good at following all safety rules and commands from range officers. This structured firing event helps children develop into safe and informed shooters later in life.

This event is an annual event that NWTFS put on which takes months of planning and countless hours of manpower to achieve. Food preparation and lawn maintenance alone take several people and many long hours. Range officers and set up crew more still as well as all the instructors. Unfortunately, awards could not be given out as the event was not completed but NWTFS is again looking forward to breaking this years record and making this an even bigger event next year.

# GAME WARDEN FIELD NOTES NOV. 19, 2021 TPWD NEWS

### HOLD THE PEPPER

In September, a Bexar County game warden received a call from Austin communications about dove hunters peppering local residences with shotgun pellets. Upon arrival to the field, the warden observed two gentlemen hunting. As he drove up to the individuals, one of the gentlemen stood up and shot a bird that fell a few yards from him. The warden proceeded to complete a hunting check. He spoke with the individual and asked if he was aware of the type of bird he had just shot. The hunter did not know. The warden informed him that the bird was an American kestrel, a protected bird of prey, and is not allowed to be hunted or harvested. The warden checked the other hunters in the group and discussed the issues around peppering, ensuring their shotgun pellets did not cross property lines. A citation was issued for harvesting a protected species. The case and civil restitution are pending.


