### 2024 BOYS DEER HUNT

Your NWTFS held another successful boys Deer Hunt on December 7-8th/2024 in Jack County. This hunt is the largest, longest continuously held youth hunt in Texas, having started in 1966. This is not a parent/child hunt, but the youth are guided/mentored by experienced hunters! We stress gun safety, game laws/licensing, deer behavior/identification, ethical hunting, conservation, etc. Of course, it couldn't happen without the help and cooperation of many others! We are blessed with caring and giving land owners such as the David Woods family (4-Amigos Ranch), Mike Campsey (South Campsey Ranch), Will Mangum (Happy C Ranch), Park Ranger Robert Frie (Ft. Richardson State Park), and all of their workers! Certainly would like to thank all of our guides who not only guide, teach, and mentor our youth hunters!

They are where the important interactions take place! We had 8 Game Wardens and a Wildlife Biologist there who play important roles! We also have many Field & Stream Directors who help out with this large project in a variety of ways, not the least, to cook for everyone! There are other volunteers that help with essential work around the camp that I would like to say a big thank you to!

We had 24 boys that hunted and they harvested 12 Deer. The NWTFS pays for the processing and each youth will receive an equal share of the harvest.

### VETERAN'S HOG HUNT

The NWTFS and the 4 Amigos Ranch will offer 10 disabled veterans that are members of NWTFS the opportunity to go to Jack County Ranch for an afternoon and early evening of guided hog hunting over bait from covered blinds. #### Additional Information:

- Each team member will be entered in a raffle for door prizes (must be present to win)
- Door prize raffles and hunt results will begin at 11am, Sunday (Feb. 23)
- Weigh in will be held at 3599 Coca Cola Ranch Rd Jacksboro, TX, 76458

#### Contest Rules:

- NO trapping
- NO using dogs
- NO pooling animals
- NO cap on number of animals
- All animals MUST be shot between 9 am Saturday and 9 am Sunday
- Weigh in is 9 am to 11 am Sunday. (You must have at least one team member come check your team in by 11 am, not a minute later.)
- Must follow all state and federal laws
- Ties will be broken by most head shots
- If animals have more than ONE bullet wound it will not count as a head shot
- Each team must dispose of their own animals
- Any disputes over points of stringer must be handled before leaving the judges stand
- Judges will be hunting
- Teams will be allowed to run two stands but all team members must be present at the time of weigh in (unless discussed before hunt with judges)
- Main pot pays 1 spot if less than 10 teams
- Main pot pays 2 spots if 10-20 teams
- Main pot pays 3 spots if more than 20 teams
